As Chief Medical Information Officer for the Cleveland Clinic health system, Dr. David Levin focuses on information systems, knowledge management and clinical transformation. He has more than 20 years of experience in diverse areas including quality improvement, patient safety, hospital and group practice operations, credentialing and population management. He also brings to bear more than 25 years of experience in information technology and has worked with a wide variety of clients in the development of clinical and educational IT applications. From 2008 to 2011, Dr. Levin served as the Vice President for Medical Informatics for Sentara Healthcare, a non-profit integrated delivery system based in Virginia. During that time, Sentara implemented a regional health information organization based on the EPIC EMR, achieved HIMSS Analytics Level 7 certification and won the HIMSS Davies Award (2010). Dr. Levin holds degrees in biology and medicine from Brown University. He completed his residency in family and community medicine at Brown in 1991 and a fellowship in academic family and community medicine at Eastern Virginia Medical School in 1994. He is also a former Vice Chairman for Clinical Affairs in the Department of Family and Community Medicine at Eastern Virginia Medical School. Dr. Levin has served on multiple boards of directors including the Comprehensive Health Investment Project of Virginia and Chesapeake Bay Academy.
