Biography

Nathaniel Grow is an Associate Professor of Business Law and Ethics and the Yormark Family Director of the Sports Industry Workshop. He previously served as an Associate Professor of Legal Studies (with tenure) at the University of Georgia's Terry College of Business. He was also a cum laude graduate of the University of Michigan Law School, where he served as a contributing editor to the Michigan Law Review. Nathaniel's research interests include legal issues in the U.S. sports industry -- including the application of federal antitrust, intellectual property, labor, and employment law to the professional sports industry -- along with the field of U.S. intellectual property law. The author of more than 20 law review articles, as well as an award-winning book, his academic work has garnered a number of prestigious research honors, including the David J. Langum, Sr. Prize in American Legal History, as well as the Distinguished Junior Faculty Award from the Academy of Legal Studies in Business. A nationally recognized expert in the field of sports law, Nathaniel is frequently quoted by media outlets such as the Washington Post, Wall Street Journal, and ESPN regarding current legal issues in the sports industry. Prior to entering academia, he previously practiced law in the Washington, D.C. office of the firm of Crowell & Moring LLP, where he specialized in intellectual property and antitrust litigation.
